This is in response to your request dated Feb. 14, 2017, regarding your tax-exempt status.

IRC Section 6033(j) provides that, if you don't file a required annual information return or notice for three consecutive years, your exempt status will be automatically revoked on the filing due date of the third required return or notice.

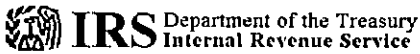

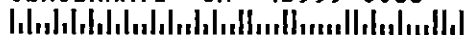
